I. OPENING OF MEETING

Mr. Chad Chitester, President of the Board, opened the meeting at 6:35 p.m. and led the Pledge of Allegiance.

Mrs. Patti reported for Mr. Matthew Moore, Chairperson of Special Education. She noted that the Special Education Department was scheduled to have an audit, pulling 44 I.E.P.'s to review. This was prompted by the District having a 100% on a self-audit. She noted that Mr. Babcock's and Mrs. Schutte's classes attended a field trip to the Reg Lenna and the Ice Arena and Mrs. Harris' class had a field trip to the Mall to learn about selecting items within their budget, paying for items and receiving change back.

Mrs. Patti reported that she had been doing trainings with half of the faculty at the Robert H. Jackson Elementary School for the Education Elements project. Amy Caldwell and Joan Waterman have been assisting and are well respected, exceptional teachers. On January 17th the other half of the faculty will receive their training.

Mrs. Frederes announced that Mrs. Burns had a Public Speaking Contest with Aurora Treacy and Heather Russell moving forward to compete at JCC. She noted that 20 weeks progress reports were mailed and that Mr. Gray and she had met with parents of 40 students. These meetings were well received by parents.

Mrs. Morrison announced that the Robert H. Jackson Elementary school has been busy with Santa Secret Shop, Pajama Day, Concerts and Grandparent's Day. The cafeteria served 74 grandparents' lunches at the Grade Three Grandparent's Day. She also reported that Dawn Ekstrom, Elementary School Nurse was audited by the Department of Health and received a score of 100.

Mr. Caldwell announced that the Middle/High School had held their Holiday Concerts and that the Holiday Basketball Tournament had been held. Three of the four basketball teams took $\mathbf{1}^{\text{st}}$ place.

He noted that Regents would be taken Tuesday through Friday the last full week in January and that not many students would be participating. Most of the students taking the exams had failed them in June and or August.

He also noted that the Junior College and Career Day would be held tomorrow with Mrs. Marzec and Mr. Blanchard working with the Guidance Department to make this happen for FCS students. Mr. Caldwell announced that tryouts for the upcoming play "It's Good Work If You Can Get It" will be taking place.

Mr. Vanstrom announced that the MS/HS Capital Project went out to bid on December 27, 2016. He noted that contractors did a walk through and that several local, Erie and Buffalo contractors were in attendance. Bid opening is scheduled for January 25, 2017. He commented that the Phase II Capital Project with Clark Patterson Lee firm consisting of the bus garage, parking lot and RHJ renovations would be going out to bid late April or early May 2017.

He also announced that Mr. Sitler, Mrs. Patti, the Guidance Office and he have been working on two college courses, Psychology and Sociology, through JCC for our students to earn 6 hours of college credit for each course.
